MEMORANDUM OF UNDERSTANDING (MoU)

The MoU is made on the 4th of November month in the year 9.020, at Patna, between, MAGADH MAHILA COLLEGE, Patna, a constituent college of Patna University, Patna, which is officially represented by the Principal, and include his/her successor in office, legal representative nominee and assignce as the "First Party"

MEDHA LEARNING FOUNDATION (hereinafter referred as "Medha"), Lucknow, registered as a not-forprofit Company under Section 8 (erstwhile Section 25) of the Companies Act, 2013, which expression shall include unless excluded by or repugnant to the context, mean the Executive Director, and include his/her successor in office, legal representative, nominee and assignee as the "Second Party."

WHEREAS

The Second Party, in collaboration with the First Party, shall be implementing an array of Programme (the "Programme"), details of each Programme shall be mutually agreed upon separately. They shall be mentioned in the "Programme Plan" annexed at the end of the MoU.

1. COMMENCEMENT, COMPLETION, MODIFICATION, AND TERMINATION OF THIS MOU

- 1.1 The purpose is to establish further collaboration between both the parties under the terms mentioned in various sections of the MoU as an extension to the MoU signed between Patha University and Medha on 3rd April 2019.
- 1.2 This MoU shall come into force from the date of signing, or other earlier dates that is mutually agreed by the two parties.
- 1.3 Modification of the terms and condition of this MoU, including the modification of Programme may only be made by prior written agreement between the parties.
- 1.4 This MoU shall be valid for the period of Three years from the date of signing this MoU or, which might be extended, based on mutual agreement.

The involvement of Medha and the role of college will be as per following:

2. ROLE & OBLIGATION OF THE SECOND PARTY IN SUPPORT OF PROGRAMMES

- 2.1 The Programme shall be delivered exclusively to the students, alumni, and faculty (as the case may be) of the college through either of the two models available at Medha online/virtual delivery and offline/on-campus delivery.
- 2.2 Medha shall provide training bootcamps, mentorship, industry exposure, internships and available employment opportunities to interested students in order to enhance their employability, entrepreneurship and employment outcomes.
- 2.3 The Programme shall run throughout the academic year and shall offer different opportunities as represented in the Programme Plan agreed upon from time to time and annexed at the end of the MoU.
- 2.4 Medha shall collect Rs. 500 (Rupees Five Hundred only) as Student Contribution per student per module for availing the Programme offering. The documentation with regard to the same would be shared with students and the college.
- 2.5 Medha shall abide by all the terms and conditions mutually agreed upon with the college in the implementation of the Programme.
- 2.6 Medha shall furnish all relevant information, progress report and documents corresponding to the project, to the college as and when required or demanded by the latter
