

Memorandum of Understanding (MoU)
Between

And
Dr. Shyama Prasad Mukherjee University, Ranchi, Jharkhand

This Memorandum of Understanding (MoU) is made and entered into on this 24 day of May, 2024, by and between Magadh Mahila College, Patna University, hereinafter referred to as "MMC," and Dr. Shyama Prasad Mukherjee University, Ranchi, Jharkhand, hereinafter referred to as "DSPMU."

Purpose

The purpose of this MoU is to foster mutual cooperation and collaboration in the areas of research, teaching, and the learning process, ensuring the development of students, faculty, and institutional growth.

Scope of Collaboration

1. Research Collaboration

2. Teaching-Learning Enhancement

- Organizing workshops, seminars, and conferences for students and faculty development.
- Development and implementation of innovative teaching methodologies.
- Exchange of teaching materials and course content.

3. Student and Faculty Exchange

- Opportunities for student exchange programs for academic enrichment.
- Faculty exchange programs to share expertise and teaching practices.
- Collaborative internships and training for students.

4. Library and Resource Sharing

- Reciprocal access to library resources, digital archives, and e-learning materials.
- Development of a shared digital repository of academic content.

5. Capacity Building Programs

- Joint initiatives for skill development, leadership training, and career counseling.

- Collaboration in entrepreneurship and innovation programs.
6. Monitoring and Evaluation

- Formation of a joint committee to oversee the implementation and progress of collaborative activities.
- Regular reviews and feedback sessions to ensure effective collaboration.

Terms and Conditions

1. Duration

This MoU shall remain in effect for a period of five (5) years from the date of signing, with the possibility of renewal upon mutual agreement

2. Funding

Each party shall bear its own expenses unless otherwise mutually agreed upon in writing.

3. Confidentiality

Both institutions agree to maintain the confidentiality of sensitive information and intellectual property shared during the collaboration.

4. Amendments and Termination

This MoU may be amended or terminated by mutual consent of both parties. Either party may terminate this agreement with prior written notice of at least three (3) months.
