 POWER PURCHASE AGREEMENT (PPA)
 (PROJECT)

This Power Purchase Agreement (PPA) is executed on _____ date of _____ month of 2018 year at Magadh Mahila College Near Gandhi Maidan Patna, pin - 800004, between (hereinafter referred to as "Purchaser") AND M/s. SURYAM INTERNATIONAL PRIVATE LIMITED. (CIN No. U40106BR2015PTC019480) a company incorporated under the Companies Act, 2013 having its registered office at H/O - M. Shivaji, 2nd Lane, Gandhi Nagar, Berhampur, Odisha - 760 001 (hereinafter referred to as "Power Producer" which expression shall, unless repugnant to the meaning or context hereof, be deemed to include its successors and assigns). The Purchaser and Power Producer are each individually referred to as a "Party" and collectively as the "Parties".

WHEREAS:

- A. The Power Producer has been notified as successful bidder by SOLAR ENERGY CORPORATION OF INDIA LIMITED for "Design, Manufacture, Supply, Erection, Testing and Commissioning including Warranty, Operation & Maintenance of 135 KWp Rooftop Solar PV System in RESCO Model Magadh Mahila College Near Gandhi maidan Patna pin - 800004 (and as per competitive bidding under RFS No. SECUC&P/MNRE/1000MW RT/IND/122015 dated 09/12/2016.
- B. The Power Producer is engaged in the business of design, supply, erection, testing, commissioning, operating and maintenance power plants, including grid connected rooftop power projects.
- C. The Power Producer has agreed to install and operate a solar photovoltaic power plant of 135 KWp capacity at the Premises after due inspection of the Premises as defined hereinafter and supply the entire Solar Power of the Project to Purchaser on the terms and conditions contained in this Agreement.
- D. The Purchaser has agreed to purchase the entire Solar Power of the Project on the terms and conditions contained in this Agreement.
