

2. Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his behalf. A copy of such authority should be enclosed along with the bid.
3. Bidder(s) can inspect the articles/items between 10.00 a.m. to 3.00 p.m. at Magadh Mahila College Campus, North Gandhi Maidan, Patna- 800001 from 03.12.2023 to 11.12.2023 (except Sunday and Holidays) in regard to the conditions, quality etc. of the articles/items and satisfy themselves before submitting their offer by the date and time specified.
4. Any tax is livable shall be paid by the successful bidder.
5. All articles/items will be sold on “AS IS WHERE IS BASIS” will be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality and quantity of the articles/items proposed to be auctioned.
6. The successful bidder will be required to make full payment of bid by way of Demand Draft/Banker’s Cheque drawn on any Nationalize Bank (payable at Patna) in favour of **Principal, Magadh Mahila College, Patna within 10 days** after the finalization of the bid and **will have to collect the articles within fifteen days from the date of submission of the Demand Draft, otherwise the his/her bid will be cancelled and the offer may be given to the next highest bidder, if the University thinks deemed fit.**
7. The successful bidder will not be entitled to resell any of the articles/items while they are still lying within the premises of this University and no delivery would be effected by this Office to any person or person(s) other than the bidder whose name/names are mentioned in the Order.
8. The scrap items/articles will be sold in one lot. The bidders shall quote the rate for one lot ie, after totaling the lot along with this tender document.
9. The bidder who has quoted maximum price, subject to the condition that fixed by this University, shall be considered as successful bidder.
10. Sealed Envelopes should contain the Bid form, Declaration and the cover should be super scribed as “Sale of scrap materials” at Magadh Mahila College Campus, North Gandhi Maidan, Patna-800001 and may drop in person or by post in the tender box on or before 12.12.2023 by 4.00 PM at Magadh Mahila College Campus. This office shall not be responsible for any delay.

11. No bid shall be accepted after the due date and time. If the due date happens to be a holiday the bid due date will be next working day at the same time notified as above.
12. The auction shall be subject to the Indian laws and jurisdiction of the Courts located in Patna.
13. The undersigned reserves the right to postpone the date of opening or accept or reject any or all the bids without assigning any reason at any stage.
